## Russia's highest civilian award for Modi



Kyiv: Prime Minister Narendra Modi has received the highes civilian award from Russia. Russian President Vladimir Putin on Fuesday formally awarded Prime Minister Modi with his country's highest civilian award, the Order of St. Andrew the Apostle, for his efforts to enhance bilateral relations between the two countries. Putin presented the award to Prime Minister Modi at a special event held at St. Andrew's Hall in the Kremlin. Russia announced this award in 2019. Narendra Modi is the first Indian leader to be selected for this civic award. A ward was established in 1698. The award was instituted by Tsar Peter the Great in honor of Saint Andrew, the chief disciple of Jesus Christ. Meanwhile, Prime Minister Narendra Modi expressed his happiness on receiving Russia's highest civilian award. He expressed his gratitude for being selected for the award. Modi said that this is to honor not only him but also 140 crore Indians. He described it as a tribute to the centuries-long friendship and mutual trust between India and Russia. The Russian Presi dent had then said on X, "Indian Prime Minister Narendra Modi received the Order of St Andrew for outstanding achievements in promoting partnership with Russia". To this, PM Modi replied that the foundation of the friendship between the two countries is deep and the future of the partnership is bright.

# 'Not Charity, Right': SC's Big **Alimony Order For Muslim Women**

New Delhi: A divorced Muslim woman can seek alimony from her husband under Section 125 of the Code of Criminal Procedure - the law related to maintenance for wives - the Supreme Court ruled today. The big judgment came as a bench of Justice BV Nagarathna and Justice Augustine George Masih dismissed a Muslim man's petition challenging a direction to pay his wife maintenance after divorce. "We are hereby dismissing

the criminal appeal with the major conclusion that Section 125 would be applicable to all women and not just married women," Justice Nagarathna said. Justice Nagarathna and Justice Masih delivered separate, but concurrent, judgments. The bench made it *clear that the law for seeking* maintenance applies to all married women, irrespective of their religion. Section 125 broadly says a person with sufficient means

cannot deny maintenance to

their wife, children or parents. Maintenance is not a matter of charity but a fundamental right of married women, the court said. "This right transcends religious boundaries, reinforcing the principle of gender equality and financial security for all married women," it added. "Some husbands are not conscious of the fact that the wife, who is a homemaker, is dependent on them emotionally and in other ways. Time has come for Indian men to recognise the indispensable

role and sacrifices made by housewives for the family.' Rekha Sharma, chairperson of the National Commission for Women, has welcomed the judgment. "NCW Chairperson, Ms. Rekha Sharma, wholeheartedly welcomes the Supreme Court's landmark ruling affirming the right of Muslim women to seek maintenance under Section 125 of the CrPC. This decision is a significant step towards gender equality and justice for all women," the panel said in a post on X.

## **Trainee IAS Officer, Who Used Siren On Private Car, Claimed Mental Disability**

Mumbai: Puja Khedkar - an on-probation Civil Service officer - claimed to be visually and mentally impaired in an affidavit submitted the Union Public Service Commission to avail selection process concessions. She had refused, six times, to undergo a mandatory medical test to confirm her disabilities. It is unclear how, or why, she was appointed if she, in fact, declined to appear for the examination. Unconfirmed reports say the first test had been scheduled at Delhi's All India Institute of Medical Sciences for April 2022. She skipped this claiming to have tested positive for COVID-19.

Two appointments for the following month were also skipped, as were those in July and August. And she only halfattended a sixth in September; she did not appear for a MRI test to assess vision loss. The Commission subsequently challenged her selection and, in February 2023, a tribunal ruled against her. Nevertheless, somehow she managed to have her civil service appointment confirmed. There are also questions over Ms Khedkar claiming OBC, or Other Backward Classes, status. The falsified statements - and allowances so gained - allowed Ms Khedkar to pass the uber-competitive Civil Services Exam despite scoring a relatively low all-In-

dia rank of 841. Ms Khedkar was transferred



from Pune to Washim after her 'exploits' - including the use of a siren on her private vehicle, an Audi luxury sedan - came to light. Pune Collector Suhas Divase had written to the Chief Secretary of the Maharashtra government to request Puja Khedkar's re-assignment.

## Maharashtra 'Pawar' Play: How Ajit Pawar Is Planning To **Revive NCP and Win Prestige Battle Against Sharad Pawar?**

Mumbai: On June 4, when the results of the Lok Sabha Elections were announced, Ajit Pawar-led Nationalist Congress Party was expecting that the people of Maharashtra would understand his choice of rebellion and support him in the polls. However, in a shocking turn of events, the NCP could win just one Lok Sabha seat of the four it contested. On the other hand, the NCP (Sharadchandra Pawar) bagged eight out of 10 seats it contested. The election was a test for Ajit Pawar as he was leading the NCP in the first Lok Sabha polls after its split last year. Ajit Pawar even fielded his wife Sunetra against cousin sister Supriya Sule but lost the Baramati seat. Ajit Pawar knows that the NCP has failed in its debut test and if he doesn't act, then it may go further downhill in the upcoming state assembly elections. With only three months left for the Maharashtra assembly elections, Ajit Pawar has decided to turn the fortunes in his party's favour. The NCP is facing stiff competition from NCP-Sharad Pawar. Ajit Pawar is facing twin challenges - first to woo the voters and second to overcome the Sharad Pawar conundrum.

Ajit Pawar warmly welcomed the Sant Tukaram Maharaj Palkhi, part of the Pandharpur pilgrimage, to his hometown of Baramati. True to his promise made in the Assembly to walk with the pilgrims, or 'warkaris,' when they passed through Baramati, the Deputy Chief Minister joined them in traditional attire, accompanied by his wife, Sunetra. Furthermore, the Budget he presented as Finance Minister last week included a special allocation for the warkaris - Rs 20,000 for every 'dindi' (group) participating in the Sant Dnyaneshwar Maharaj and Sant Tukaram



Maharaj palkhis to Pandharpur. Ajit Pawar knows that he will have to be on the ground if he wants to make the NCP race ahead of the rival faction. Speaking to reporters recently, Ajit Pawar said that he will start campaigning for the Assembly elections soon. After the Lok Sabha setback, the Mahayuti comprising of the BJP, Shiv Sena-Shinde and the NCP-Ajit Pawar is banking on the monetary payout announced for women in the state Budget, on

the lines of Madhya Pradesh's

Ladli Behan yojana.

Ahead of the polls, Ajit Pawar will hold a mega rally or show of strength in Baramati on July 14 via the 'Jan Samman Rally'. NCP President Sunil Tatkare said that the party leadership will interact with party workers

to strategise future plans. In the upcoming Vidhan Sabha elections, Ajit Pawar is determined not to take any risks, as the NCP (SP) plans to field Sharad Pawar's grandnephew, Yugendra Pawar. Ajit, a seven-time MLA from Baramati, is aware of the competition within the family, with

another of Sharad's grandnephews, Rohit Pawar, currently serving as an MLA from Karjat-Jamkhed Ahmednagar district.

By catalysing the grassroots workers and making his presence felt in Baramati, Ajit Pawar is trying to send out a message that he is down but not out. The NCP is confident that the Lok Sabha election results would have no bearing on the state assembly polls. With both - Ajit Pawar out on the battlefield to strengthen his factions, all eyes on Sharad Pawar's next move.

## **BMW Hit-And-Run: Accused Mihir Shah In Custody Till July 16; Girlfriend May Face Detention**

Mumbai: A Mumbai court has sent Mihir Shah, the main accused in the Worli hit-and-run case, to police custody till July 16. After a rigourous search, Mihir Shah was arrested from Virar on Tuesday. Thereafter, he was brought to Sewri court in Mumbai on Wednesday. Shah had been absconding after the car he was allegedly driving hit a scooter on Dr Annie Besant Road in Worli on Sunday, July 7.

After ramming the couple on a scooter with his BMW, Mihir Shah spoke to his girlfriend 40 times before abandoning the car. Police said the girlfriend may now be detained for questioning. Fourteen teams were formed by Mumbai police to nab him. Police arrested Rajrishi Singh Bidawat and Mihir's father, Rajesh Shah, for their alleged involvement in the case. Following the tragic incident, the deceased woman's husband, Pradeep Nakhwa, questioned the delay in the arrest of the accused and alleged that he dragged his wife from Ceejay House to Sea Link Road.

"It was due to 'politics' and the accused would not be arrested until the Vidhan Sabha

session ends," Nakhwa had claimed. He also alleged that the delay in the arrest was because the accused was the son of a political leader.

In an exclusive interview, Nakhwa said, "We were on our daily routine, as we are fishermen, and as part of our daily routine, on Sunday at 4 am, we were returning through the Peddar Road from the fish hatchery after buying fish. We were riding slowly at a speed of 35-40 km/hr on the side of the road. Suddenly, a car at high speed came and hit us; we didn't even realize how fast it was. We flew into the air and dropped on his car's bonnet."

"When he applied the brake, I fell on the left side of the road while my wife came under the wheels of his car. He didn't stop after that; I tried to stop him, but he didn't and dragged her from Ceejay House to Sea Link Road. There was smoke from the wheels when he was dragging my wife. After the incident, he fled from the spot," said Nakhwa.

According to Mumbai police, the 45-year-old victim was a resident of Worli Koliwada. Her husband was riding the scooter while she was riding the pillion. The husband also sustained injuries in the incident. "The couple was returning home after buying fish when the scooter they were riding on was hit by the luxury car. Both of them sustained injuries, and the woman died during treatment," police added.

Police also said that the luxury car belonged to a leader of a political party based in Maharashtra's Palghar. The incident in Worli follows less than two months after the Pune case in which a luxury car allegedly driven by a 17-year-old youth, who was allegedly under the influence of alcohol, rammed into a motorcycle, resulting in the deaths of two software engineers in Pune's Kalyani Nagar area in the early hours of May 19.

Maharashtra Chief Minister Eknath Shinde expressed his 'alarm' at the 'rise in hit-andrun incidents' in the state on Monday and said that he has directed the police to take strict action against such cases, adding that the 'guilty will not be spared'. The Shiv Sena also removed Rajesh Shah the father of the accused from the party following his arrest.

### **Times After BMW Crash, She May Be Detained** Mihir Shah Called Girlfriend 40

Mumbai: In a very short span after he rammed a couple on a scooter with his BMW, killing the woman who was riding pillion, Mihir Shah spoke to his girlfriend 40 times before abandoning the car, hailing an auto and heading to her house. Police said the girlfriend may now be detained for questioning.

The 24-year-old son of a Shiv Sena (Eknath Shinde faction) leader crashed his BMW into a scooter in Worli in which Pradeep Nakhwa and Kaveri

Nakhwa, a fish-seller couple, were returning around 5.30 am on Sunday after buying fish to sell during the day. While Pradeep was flung off the bonnet after the car hit him, Kaveri came under the wheels and was dragged for 1.5 km. Shah, who was allegedly drunk. then switched seats with his driver, Rajrishi Bidawat, and they reversed the car over Kaveri before speeding away. Shah and the driver then went to Kala Nagar in Bandra, where they

abandoned the car and took off the number plate to avoid being caught. While all this was happening, an official said, Shah called and spoke to his girlfriend 40 times. After leaving the car in Kala Nagar, the 24-year-old hailed an auto and went to his girlfriend's house in Goregaon. Police said he "rested" there for two hours while his girlfriend informed Shah's sister about the accident. His sister went to Goregaon and then took Shah

to their house in Borivali.

From there, Shah's mother, Meena, two sisters - Puja and Kinjal - and a friend, Avdeep, left for a resort in Shahpur, nearly 70 km from Mumbai. They hid there while the police kept looking for Shah, having arrested his father Rajesh Shah and the driver, Bidawat.

On Monday night, Shah left for the family's house in Virar and, the next morning, Avdeep turned on his phone for 15 minutes, revealing his location.

This led to Shah's arrest.

While Shah was produced in court and sent to police custody till July 16, police said they may also detain his girlfriend to question her. An official said the questions will centre around what information about the accident was shared with her by Shah, and whether he was drunk when he spoke to her and met her. The Worli hitand-run, which came close on the heels of the Pune Porsche

accident, has led to questions being asked of the government. While the juvenile is on the Porsche case is on bail after killing two 24-year-old techies, Mihir Shah also managed to evade the police for 72 hours. In both cases, the opposition has alleged that the accused have links to people in the state government, which is being run by a coalition of the Eknath Shinde faction of the Shiv Sena, the BJP, and the Ajit Pawar-led faction of the NCP.

# **Telangana Govt under fire for risky financial move**

Hyderabad: The Revanth Reddy government came under fire from the opposition BRS, for resorting to risky measures by mortgaging prime lands to raise funds for fulfilling electoral promises. The party leadership further expressed concerns about the appointment of a merchant banker as an intermediary, reportedly receiving a commission of Rs 100 crore. According to media reports,

the State government is planning to mortgage 400 acres of government land, worth Rs 20,000 crore, to private finance companies to secure a loan of

Rs 10,000 crore. This land, belonging to the Telangana State Industrial Infrastructure Corporation (TSIIC), is primarily located in the economically significant areas of Kokapet and Raidurg. BRS working president KT Rama Rao criticised the State government for its inability to manage the State finances efficiently. "Such thoughtless actions will cripple the progress of Telangana. There will be no new investments, industries, or jobs, jeopardising the future of our children," he posted on X. Rama Rao pointed out that most of the IT industries are coming

in areas like Kokapet and Raidurg. Mortgaging 400 acres in such a prime locality to private companies is an ill-advised move, he remarked. He said the industrial sector in Telangana has been stagnant for the past seven months, with no new investments and existing companies not receiving proper incentives. He questioned the impact of mortgaging industrial lands on the future of these companies and the State's youth seeking employment. In a separate post, the former Minister also highlighted the stalled progress of the 'Eco Park' project on the

Himayatsagar Lakefront at Kothwalguda near Hyderabad. Launched in October 2022, this ambitious 125-acre project included attractions like India's largest aviary, an aquarium, boardwalks, landscaped parks, and weekend camping facility among others. However, the project has come to a standstill in recent months due to a lack of support from the current administration. "I urge Chief Minister Revanth Reddy to take this project forward and make sure Hyderabadis have a great family getaway as we had conceptualised," he said.

## **KTR urges CM to complete the Eco Park Project at Kothwalguda**

Hyderabad: Former Municipal Administration and Urban Development (MA&UD) Minister KT Rama Rao has called upon Telangana Chief Minister A Revanth Reddy to complete the Eco Park project on the Himayat Sagar Lakefront at Kothwalguda, near Hyderabad. He remarked that the ambitious project, initiated under the Bharat Rashtra Samithi (BRS) administration, has come to a halt since the party left office last year.

In a post on his social media handle X (formerly Twitter), KT Rama Rao expressed his concerns, stating, "We had launched an ambitious project called the 'Eco Park' on the Himayat Sagar Lakefront at Kothwalguda near Hyderabad in about 125 acres with attractions such as India's largest aviary, an aquarium, boardwalks, landscaped parks, and weekend camping options. The project was launched in October 2022 and works were progressing until we relinquished office. Now, I've learned that

## **Muslim women have right** to seek maintenance from spouse, rules SC

New Delhi: The Supreme Court ruled that a Muslim woman can seek maintenance from her husband under Section 125 of the Code of Criminal Procedure (CrPC), which is applicable to all married women irrespective of religion. A Bench of Justices BV Nagarathna and Augustine George Masih, which pronounced a separate but concurrent verdict, said Section 125 of the erstwhile CrPC, which deals with wife's legal right to maintenance, covers Muslim women. "We are hereby dismissing the criminal appeal with the major conclusion that section 125 would be applicable to all women and not just married women," Justice Nagarathna said while pronouncing the verdict. The Bench said maintenance is not charity but the right of married women and it is applicable to all married women irrespective of their religion. The top court dismissed the petition of one Mohd Abdul Samad, who has challenged the order of the Telangana High Court refusing to interfere with the maintenance order of the family court. He has contended that a divorced Muslim woman is not entitled for maintenance under Section 125 of CrPC and has to invoke the provisions of the Muslim Women (Protection of Rights on Divorce) Act, 1986.

"Many of our customers feel hesitant to walk in because they think board games are only for intelligent people. However, that's not true at all. We're here to teach you everything, and you'll be pleasantly surprised by the experience," says Aditya, who juggles between being an advocate and a game master. Explaining their choice of Himayathnagar, Ravali mentioned that they wanted to introduce an engaging activity spot in that part of the city, which is ripe for such spaces.

"Playing games always gave us stories to talk about. We realised that board games draw people of all age groups together. We've seen grandparents and grandkids, parents with their kids, newlyweds with their in-laws. Everyone can bond over board games," added Ravali, who is on a break from her medical career.

Looking ahead, they aim to build a board gaming community in Hyderabad, plausibly via WhatsApp, where strangers can meet, play games, and bond over shared interests.

## 18 killed, 19 injured as speeding sleeper bus hits milk tanker in UP

Unnao: Eighteen people died and 19 were injured when a double-decker sleeper bus hit a milk tanker on the Agra-Lucknow Expressway, police said. The accident took place around 5 am near Jojikot village in the Behta Mujhawar police station area. District Magistrate Gaurang Rathi said prima facie the bus, which was on its way to Delhi from Bihar, was speeding and hit the milk tanker from behind. A probe has been launched into the matter, he said. Bangarmau Circle Officer (CO) Arvind Kumar said due to the impact of the collision, both the bus and milk tanker over-



turned. Drivers of the two vehicles were among the dead. He said the injured were rushed to a hospital

and their condition was stated to be stable. Police are trying to identify the victims.

### First case of sex change in Indian **Civil Services: Woman IRS officer** posted in Hyderabad turns man

Hyderabad: A woman Indian Revenue Service (IRS) officer, serving as the Joint Commissioner in the regional bench of the Customs, Excise and Service Tax Appellate Tribunal (CESTAT), Hyderabad, has turned a man. This is said to be the first case of a sex change in the Indian Civil Services. The Ministry of Finance has accepted the request of M Anusuya for change of her name to M Anukathir Surya and gender from male to female. "The request of Ms M Anusuya has been considered. Henceforth, the officer will be recognised as 'Mr M Anukathir Surya' in all official records," reads the order issued by the Ministry of Finance, Government of India, on July 9. The 35-year-old officer, posted as Joint Commissioner in the office of the Chief Commissioner (Authorised Representative) of CESTAT, had joined his current posting last year. Surya started his career as an Assistant Commissioner in Chennai in December 2013, and was promoted to the rank of Deputy Commissioner in 2018. He completed his Bachelor's degree in Electronics and Communication from the Madras Institute of Technology in Chennai. He did PG Diploma in Cyber Law and Cyber Forensics from the National Law Institute University in Bhopal in 2023. The Supreme Court, in its judgment in the NALSA case on April 15, 2014, had recognised the third gender and ruled that gender identity is a personal choice, whether or not a person undergoes Sex Reassignment Surgery (SRS).

## Rahul Dravid Reduces His T20 World Cup Bonus By Rs. 2.5 Crore, Wants Equal Reward

The 'gentleman' Rahul Dravid has given another fine example of his character, deciding to let go of half of the INR 5 crore prize money that he was to get from the pool of Rs. 125 crore that the Board of Control for Cricket in India (BCCI) announced for the T20 World Cup-winning Indian team. After Rohit Sharma's men beat South Africa in the final to clinch the title, the BCCI announced that a total of Rs. 125 crore will be given to the team, coaching staff, and support staff as a cash reward. The cut for head coach Rahul Dravid came out to be INR 5 crore while the other coaches in the team were to be given Rs. 2.5 crore.

Dravid asked the board to reduce his cash reward to Rs. 2.5 crore too as he didn't want to get more money in comparison to the batting, bowling, and fielding coaches. "Rahul wanted the same bonus money (Rs. 2.5 crore) as the rest of his support staff (bowling coach Paras Mhambrey, fielding coach T Dilip and batting coach Vikram Rathore). We respect his sentiments," a BCCI source



said, as per the report.

What's to be noted is that Dravid had taken a similar stance as the head coach of India's winning U-19 World Cup team of 2018. At that time, Dravid was to get INR 50 lakh while the other members of the support staff were to get Rs. 20 lakh each. The players were to earn Rs. 30 lakh each, as per the formula. Dravid refused such a bifurcation, forcing the BCCI to change the

first Wimbledon title, he said: "Hopefully I'm going to get the


